

FCA POOL RULES

POOL HOURS: 9:00 AM – 9:00 PM

The use of the pool is limited to FCA MEMBERS ONLY who are in “good standing,” have signed a waiver, initialed pool rules, and have paid pool membership fee. (This includes payment of a one-time pump escrow fee.)

All members and guests using the pool do so AT YOUR OWN RISK, and release FCA from any and all liabilities for personal injuries, loss, or damage to property occasioned by the use of said facilities. We DO NOT have a LIFEGUARD on duty!

GENERAL:

_____ Initials

- NO ALCOHOLIC BEVERAGES ALLOWED!
- NO SMOKING OR VAPING!
- No glass items are permitted in the pool area.
- No bicycles, skates, scooters, or any similar items are permitted.
- No animals or pets are permitted inside the pool fence.
- No petting, profanity, or offensive conduct on pool premises will be permitted.
- No eating or drinking is permitted in the pool.
- No running, diving, pushing or any type of horseplay is permitted.
- The life preserver is NOT a toy. DO NOT allow children to play with it!
- No small splash balls – they get caught in the skimmer

GUEST RULES:

- A MEMBER MUST accompany all guests.
- Members can only bring in 3 guests. Exceptions can only be made by Pool VP.
- No guest may enter or remain at the pool without a member present.
- Pool cards should not be given to a guest under any circumstances.
- A FLAGSTONE RESIDENT THAT IS NOT A POOL MEMBER CANNOT BE A GUEST!
- Members are responsible for the conduct of any member or guest. Poor conduct could result in family membership suspension with NO REFUND.

_____ Initials

TEENS:

- Pool members who are 14 and older are allowed at the pool without an adult member.
- Pool members between 14 and 18 can bring a maximum of 2 guests of any age without a parent or legal guardian.

FURNITURE:

- Pool furniture is NOT to be placed in the pool for any reason.
- Pool lounge chairs are not to be walked on for any reason.
- Pool furniture is not to be jumped over for any reason. This could result in a fine, or membership suspension with NO REFUND.

PERMISSABLE ITEMS:

- Use of floatation devices will depend on the size and the crowd in the pool.
- Only appropriate pool toys are permitted.

ALWAYS:

- Members and their guests are responsible for cleaning up after themselves.
- The pool team families are responsible for cleaning the pool and the bathrooms only.
- PLEASE NOTIFY A POOL TEAM MEMBER ASAP. If your child has an accident (diarrhea, vomit, bloody nose, etc..) please clean this up immediately. Any blood also must be cleaned up immediately and sanitized with Clorox – All trash is to be placed in trash can...PLEASE!
- Everyone must obey all federal, state and local laws and regulations.
- All children not fully potty trained are REQUIRED to wear a LEAK-PROOF SWIM DIAPER.
- If feces is found in pool, it must be closed for 24 hours for sanitation.
- Shower before entering the pool.
- Rinse off sand in shower before entering pool fence.
- Keep both gates closed. Propping open the gates is NOT PERMITTED.

PARTIES:

- Pool dates are at a first come, first serve basis at the day of pool registration (May 12th).
- The fee for a private pool party is \$75.00 AND must be paid when reservation is made.
 - *Private Parties* - will be scheduled on Monday nights from 6 p.m. – 9 p.m. The pool will close to all members when a private party is scheduled
- The fee for non-private pool party is \$50.00 AND must be paid when reservation is made.
 - *Non-Private Parties* – are available on Wednesday nights from 6 p.m. to 9 p.m.. The pool will not be closed to the pool members.
- NOTE: The pool area must be left clean and trash bagged and taken home with you.
- Make checks payable to Flagstone Community Association. Give check with reservation to David King, 6723 Flagcrest Drive.
- NO REFUNDS for cancellations.
- No party reservations are available to non-members.
- Parties are only held on the predetermined Mondays and Wednesdays that have been allocated. Holding an unapproved party will result in suspension of pool facilities.

Additional rules and regulations may be adopted or these rules may be amended by a majority vote. Any infraction of these rules may result in suspension of all privileges. Fees are NON-REFUNDABLE.

All pool members and their guests are expected to demonstrate courtesies, responsibility, and respectable behavior at the pool. Failure to do so will result in your being asked to leave. If you see someone behaving in an inappropriate manner or is in violation of the rules, please say something to them! You have a responsibility. It is your pool! DO NOT sit by and allow others to destroy our investment. The more money we have to spend to repair damages means less we will have for future improvements and expansion. Any observed violation of these rules should be reported to the Pool VP, Membership VP, a pool family or a board member.

If one family receives three complaints that have been substantiated, that family's membership will be suspended WITHOUT A REFUND.
